We at Sankara faced them all, and here we are today, living the New Normal and opening up for the next wave with precautions in hand.



EYE CARE DURING THE PANDEMIC

The unprecedented pandemic threw a lot of challenges, especially because of Sankara's service delivery pattern.

Sankara handles all sections of the society, with different socio-economic status, literates and illiterates both from urban and rural interiors.

Doctors and staffs have to handle day in day out hundreds of these patients

In eye care, the medical and para medical people have to get closer to the patient's face in order to properly diagnose and treat the eye condition.

Face being the source of infection, whether from contaminated breath or saliva, our team has to work under a lot of pressure in a challenging environment.

Since inception, in the history of Sankara, unfortunately we had to stop conducting Rural Outreach Eye camps because of the pandemic

Free Eye-care, to the needy, the Gift of Vision, being the DNA of Sankara, we kept our doors open for those poor patients who would walk-in for free eye surgeries. We avoided gathering them in the camps and facilitated direct walk in for free eye care services.





Strictly adhering to the Sankara Protocol and SOPs in all departments of the hospital, Sankara managed to face the challenges successfully.

Not loosing sight of our social obligation, the entire Team Sankara came forward to donate generously to the Government's Covid Relief Fund.

Their morale has to be kept high.

There should be clear protocols and SOPs to safeguard themselves during the process of providing eye care.

The converse is also true. We at Sankara have an additional responsibility of ensuring the safety of our patients and attenders.

Sankara Academy of Vision after a thorough brain storming with all stakeholders came out with a foolproof, practical manual - "Sankara Restart".

"Sankara Restart" became the Bhagavad Gita for the entire team Sankara.

As the pandemic went from Phase to Phase, Sankara ensured the safety of everyone, keeping in mind our dictum "Atithi Devo Bhava"





UNITED IN QUALITY HEALTHCARE

To face any challenge, first we need to prepare ourselves physically, mentally and emotionally.

A sense of confidence and courage had to be instilled in the minds of the front-line warriors.

Realizing the value of the vaccination as the only tool to combat the pandemic, all units of SEFI had organized complete vaccination program for Covid for the entire medial and para medical staff and even the outsourced service personnel.

Sankara went a step further by organizing vaccination camps for immediate kith and kin of all the Employees, as our contribution to the Government's fight against the Pandemic.



Mr. Shahid Ahmed, her father, working as a private security guard was trying hard to make ends meet. Her mother, Ms Shabeena was praying to God for a miracle.

They walked in and out of many major hospitals, with the hope that their daughter would be cured. Hope was diminishing, until they stepped into the campus of SEH, Bengaluru in August of 2020.

The guidance of Mr Rajashekar, Principal, Peenya Govt School helped open the gates of Fathiya's vision free of cost.

Today, Fathiya is able to identify objects clearer and better and is able to manage her daily routine individually and confidently. The family thanked the management, doctors and the team and believe that it is all indeed.



Master Craftsman Led Towards Light and a New Lease of Life

75-year-old Mujamir Khan, from Shajahanpur, Uttar Pradesh, had serious vision problems in both eyes. Being a craftsman, his work demanded proper vision, but his vision was failing day by day.

At one stage, he couldn't see things clearly and was forced to quit work. His livelihood was in doubt. This broke the confidence and stability of Mujamir Khan's family. As the only breadwinner, he feared the future. He couldn't afford an eye surgery at a private hospital and wished desperately for a miracle.

Luckily, he heard about SEFI's free camp organized near his village. He was diagnosed with a mature cataract in both eyes.

He was operated for free and regained vision in his right eye at SEH-Kanpur and will soon be operated in the left eye too. Today, Mujamir Khan is filled with high spirits, back at work chiselling his future with renewed hope.





Back to Hope

Ms. Mala, 61-year-old daily wage worker (Match stick maker), matured cataract patient hailing from Gudiyatham, Tamilnadu.

I am thankful to the Sankara team, I got my sight back for free and was treated with utmost care and respect. Now I can work again and lead a life with dignity. May God bless all of you.

If One Door is Closed, God Opens Another

Bharath from Mudhul Village of Yadgiri district of Karnataka is a blessed child. This 11-year-old boy's vision was restored after the intervention of the Nanna Kannu Team and he is on his way towards a perfect vision.

The family had just lost their younger son to cerebral palsy when they discovered Bharath's visual impairment. They visited many leading hospitals. After various treatments, Bharath was referred to a Bengaluru hospital for advanced treatments. These treatments cost too much for them. By God's grace, through a teachers' reference, they visited Sankara Eye Hospital, Bengaluru.

'Retinoblastoma' was the diagnosis given by the doctors of SEH, Bengaluru. Then, on 8th February 2021, Brachytherapy – Vitreoretinal surgery was performed successfully and Bharath is now on the path to a better vision.

Bharath's father, Mr.Mallikarjuna gets emotional and expresses his gratitude towards Sankara. Now Bharath can walk, talk and see confidently. His grades too have improved.

Patients will be screened by the Vision Care Technician at the Vision Centre, giving the benift of Video Consultation -Secondary / Tertiary Consultation – with the Ophthalmologist at the Base Hospital.

This tele-ophthalmology facility gives a unique opportunity of virtual interaction with the Ophthalmologist to the Rural Patients, thereby minimising their travel requirements to the Base Hospital.

Patients identified with Refractive errors will be dispensed with spectacles and those who require surgical care or further treatment will be referred to the base hospital for timely intervention.

Vision Centres are the Satellite Centres surrounding the Base Hospital of Sankara and serve as a constant link between the Rural beneficiaries and Sankara Eye Hospital.

ACCOUNTING POLICIES AND OTHER NOTES 2020-21

SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements are prepared under historical cost convention and on mercantile basis and in accordance with applicable accounting standards laid down by the Institute of chartered Accountants of India and normally accepted accounting principles.

The accounting is on the basic of a going concern concept.

2. Fixed Assets

Fixed assets are stated at cost of acquisition, including attributable cost for bringing the assets to its working condition for its intended use.

Fixed assets received as contributions in kind are stated at the cost incurred by its donor and other expenses to its working condition for its intended use.

Depreciation is calculated using the straightline method over the estimated useful lives of the fixed assets as determined by the management. The loss or profit on disposal of asset is recognized in the year when the asset(s) is disposed of or the asset is condemned.

3. Investments

Investments are in the form of fixed deposits with Scheduled banks.

4. Inventories

Inventories consist of Medicines, surgical items, lens, optical, etc., Valued at cost.

5. Liabilities

Liabilities acknowledged as debt are taken into account, while contingent and disputed liabilities if any, are not provided for and are disclosed by way of a note.

6. Provision

Provision is recognized when an enterprise has a present obligation as a result of past event and is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are determined based on management estimates required to settle the obligations at the balance sheet date. These are reviewed at each Balance sheet date and adjusted to reflect the current management estimate.

7. Revenue Recognition

8. Foreign Currency Transaction

Foreign currency transaction are recorded at the rates prevailing on the date of transaction.

9. Research and development

Capital expenditure, if any, on research and development is treated in the same way as expenditure on fixed assets. The Revenue expenditure if any, on Research and Development is written off in a year in which it is incurred.

10. Retirement Benefits

 a) Retirement benefits such as periodical contribution to provident and Employees state insurance being defined contribution plans are charged to revenue on payment that had become due.

b) The Employee's gratuity is a defined benefit plan. The present value of the obligation under such plan is determined based on the actuarial valuation using the projected unit credit method which recognizes each period of service as giving rise to an additional unit of employee benefit entitlement and measures each unit separately to build up the financial obligation. The trust has an employee gratuity fund managed by trustees through Life Insurance Corporation of India.

c) Liability towards gratuity is provided and contributed to the trustees of the approved fund on the basis of actuarial valuation made and reported by actuaries of the Life Insurance Corporation of India as at the end of the year.

11. Leave benefits

Leave benefits earned by the eligible employees being accounted as and when it is paid to the employees.
